The system is used by all agencies in Huron County beginning in 2014.

THE LAW ENFORCEMENT MODULE INFORMATION IS ENTERED IN BY DISPATCHERS AND LAW ENFORCEMENT OFFICERS.

LAW ENFORCEMENT ALERT SYSTEM

THE INFORMATION IS ENTERED INTO THE RECORDS OR SYSTEM BY DISPATCHERS AND POLICE OFFICERS.

THE GREENWICH POLICE DEPARTMENT'S OFFICERS USUALLY ENTERS ALL INCIDENT RECORDS AND REPORTS. HURON COUNTY DISPATCH ENTERS 911 CALLS AND MOST TRAFFIC STOPS.

INCIDENT TYPES

THE GREENWICH POLICE DEPARTMENT INCIDENT TYPES ARE MODELED TO THE VILLAGE OF GREENWICH NEEDS.

THERE ARE 95 INCIDENT TYPES ALSO KNOWN AS CALL RECORDS. THEY RANGE FROM WELFARE CHECKS, ZONING VIOLATIONS, VEHICLE LOCK OUT, CRIMINAL OFFENSES AND TRAFFIC OFFENSES. THE FOLLOWING SLIDES SHOW THE ACTIVITIES.

- A negligence suit is filed when a person has been injured or killed or when property has been destroyed because someone else has been careless or negligent.


