Administrators Report: Virgil Giles updated council on a water main break that was repaired. Mike Gurka will have his first year of electrical lineman training completed this year and will continue on to complete the 4 year program. Greenwich received the final permit for WWTP. A quote for tree removal was received and accepted for the removal of some trees. Virgil spoke on the AEP contract for the substation. Virgil updated council on the OPWC grant application to help alleviate some the costs for the sewer project, Greenwich did not score high enough to qualify for the grant. There was nothing that the Village could have done to increase the score.

Chief's Report: Chief Dorsey states due to Covid-19 the police department is behind, now that everyone is back to work from being off due to Covid-19. Chief says he bought the building at 13 New St and would like to remodel it. Charges have been filed on the lagoon incident. There is no update on the vandalism to the cars that were recently vandalized.

Zoning Inspector: Cles spoke about a building that was placed on Kniffin St. Chief informed him that he has advised the owners to get a permit for it. Cles says he has turned in all the zoning reports to the county and zoning is going ok.

Solicitor's Report: Attorney Palmer first spoke about creating a resolution to make the Fiscal officer the public records designee for anyone who doesn't want to take the training. The Mayor advised Council that there are online courses available for anyone who wants to take the public records training and Jennifer will distribute the link to sign up for those classes. Secondly he has received some correspondence from the New London to Greenwich Rails to Trails, concerning an easement. There is some additional funding available to them and they are being held up to receive the funds due to the limited 15 year easement that was granted to them. They have sent a request to the Village asking consideration to approve a permanent easement
