Clerks Report/Correspondence: Clerk received mail correspondence concerning K9 program and passed it out to the Mayor and Council. Clerk also informed council about the approval of the American Rescue Plan Act grant of \$74,478.01.

Visitor's Addressing: Regina Lueck, 35 Orchard St, addressed council about the K9 program, she feels it would be a great opportunity for Greenwich. It could help stop human and child sex trafficking and if the program was running low on funds, she stated that she would offer help. She spoke of a situation that happened during her time teaching and strongly urges Greenwich to accept the donation. Aaron Smith, 27 Senior Dr, also spoke about the K9 program, he hopes that Council would accept this program, it is a good program, he states, as well as offering his help if needed. Chief Dorsey spoke about the K9 program and the need for the program. he stated that the program will be stopped if there are not enough donations to support the officer's wages or costs. He states that he has seen the devastation of sex trafficking, his officers have seen it as well and if this K9 program will help save a victim or child from sex trafficking it is worth it. He states he has started many programs for Greenwich and asks Council to please accept this program and donations.

Administrators Report: Virgil Giles updated Council that he will be requesting funds from COVID money for the mandate of the EPA and the laterals. The Utility department is working on hot patching. There was a water main break on Main St and a lighting strike which lost some controls at the water plant. Virgil says his department is a little behind, they are getting things done about two weeks out from what he likes to see. Question about concrete at Risner's was asked, Virgil says that is being outsourced for Columbia Gas, and there is no quote from them yet.

Chief's Report: Chief Dorsey reminded Council of another program that the Village has at the Police Department is golf cart inspections and a lot of people come to Greenwich and he wants the Department to be professional. Opto-Traffic update, they are doing things differently and the camera can be turned back on but there is an open case in Toledo and Chief recommends waiting at this time. Police logs are up to date and he will be having more patrolling done, he is finishing up investigating cases. Budget is right on and hopes nothing serious happens in Greenwich that will affect the budget. Officer Mendez will be back on August 20<sup>th</sup>, 2021.

Zoning Inspector: Mayor Sallee wanted to take the time to thank Cles Inmon for the years of service as the zoning inspector and hopes he continues to come to the meetings. Cles will be helping Virgil adjust to the new position as zoning inspector. Virgil has started to handle zoning questions and getting permits completed. Chief says that mowing violations have slowed due to rain, he is working on other zoning citations.
