Administrators Report: Virgil Giles updates council on recent water line breaks since last council meeting, he says water is back at what he likes to see. His department has replace service pumps and drained New Streets tower, filled it out and it is leveled. Water is using about 110,000 gallons a day. A company call leak seekers came and found a leak. There was an electric outage, due to lines being brittle and breaking. Ultra sonic sensors are at the lagoons and there is a repair to the lines under the bridge that ODOT replaced.

Chief's Report: Chief Dorsey says that the media release is only current to that Monday, the alert system is down. The PD is busy and no serious crimes and they are getting caught up. A police officer who gave a warning to a person with a loud exhaust had been spoken to by Chief due to new complaints of cars with loud exhausts.

Zoning Inspector: Cles Inmon says zoning is going ok, the Landbank is going to take care of the property at 19 Pierce St. Cles says he is gathering a list of properties that need to be cleaned up. Chief Dorsey has issued summons for Geneva Hunters relative due to the cars, Sanders has a summons for court. The Landbank is going to handle the situation concerning the buyer/tenant at 19 Pierce St, Chief has already told Mr. Springer he is going to have to move from Pierce as well. Mr. Springer has till this Friday to be out of the N Kniffin property, he was successfully evicted by the Wireman's. Chief is handling the garbage issue at 39 Pierce and the cars at 38 Townsend.
