Records committee met this afternoon, Attorney Palmer stated the Village is statutory compliant.

Administrators Report: Virgil Giles states the Utility department is handling a lot of calls from residents and is working in spring projects and will be working on hot patch. Surveyors are out staking for Phase E2, construction. New street will not be separated, most of the work was done in-house and 10 years ago. Even though it is staked there should be no work on New St. The reservoir dam will need an emergency action plan by the end of the year. He will get with the Mayor and Department Heads to get a plan together and everyone will need to be responsible for their part. His department is mowing like crazy and his guys are doing a lot of training. Crack sealing is coming. Virgil would like to use Covid money to remove any laterals on the private side and that will tie into us, which the money can be used for that under the infrastructure of water and sewer.

Chief's Report: Chief Dorsey stated the newer cruiser is having a service done to it. The engine is being replaced and it is at no cost to the Village. the 2020 Police Department report was delivered to council and asked for Council to please look at it. Crime stayed consistent. Juvenile and domestic complaints were up, EMS assists were higher and rape cases were higher. The police department is almost done with its remodel. It is having the new computers installed and the server is working out its bugs. He is discussing with Attorney Palmer, that he feels Council will like and will discuss that at a different Council meeting. He has given 4 mowing notices to Virgil to complete and 3 other homes that need mowed are more of a problem with finding the owners to send notices.

**Zoning Inspector:** Cles states that all the zoning permits have been sent out. He states, residents are not coming to him to get permits, he has to go and find the people who are not coming to get permits. The property at 19 Pierce St will be demolished. The landbank allowed the gentlemen to keep it. Chief Dorsey updated council on 19 Main St stating that the owner has been in contact and has 14 days to put in writing his intentions with the property. Verbally he says he wants to tear it down and realizes it is an eyesore to the Village. Chief says he would help him with permits but that he has till Friday to have a plan for the building.

**Solicitor's Report:** Attorney Palmer spoke with the new bond council and hopefully will have bond legislation and necessary opinions to Council by June 1<sup>st</sup>. Resolution No. 2021-R-08 is on the agenda due to new and revised ordinance language, received by Tim Farley, highway manager-Department of Transportation, Attorney Palmer did some housekeeping by making this a resolution not an ordinance, and stated time is not of the essence asking that it be ran through all three readings tonight. Palmer is working on an additional ordinance for Phase E2 but needs parcel numbers to complete.

**Mayor's Report:** Mayor Sallee states gun raffle tickets are available through Cles. The Memorial Day event is in the park on Saturday May 31<sup>st</sup>, at 11:00 am, please don't forget to make it if you can. An updated agenda will be given at the end of the meeting there were some changes made.
