## VILLAGE COUNCIL OF GREENWICH, OHIO ORDINANCE NO.: 2020-01

### SUPPLEMENTAL APPROPRIATION MEASURE

#### AN ORDINANCE AMENDING AND SUPPLEMENTING THE 2019 ANNUAL APPROPRIATION MEASURE

WHEREAS, Village Council previously passed Ordinance No.: 2019-03 titled Annual Appropriation Measure setting the annual appropriations for the year and providing for the current expenses and other expenditures of the village; and

WHEREAS, the Fiscal Officer reports that the Annual Appropriation Measure needs to be amended; and

WHEREAS, Section 5705.40 of the Ohio Revised Code provides that any appropriation ordinance or measure may be amended or supplemented; and

WHEREAS, Section 5705.38(A) of the Ohio Revised Code provides that during the year the taxing authority of the subdivision may pass any supplemental appropriation measures as it finds necessary; and

WHEREAS, accounting procedures provide that an ordinance by village council is necessary when the appropriation amendment will result in a reallocation of the line item amounts approved in the village's permanent appropriation ordinance [See Village Officer's Handbook, March 2019, Chapter Six: Accounting Procedures, Section IX Amending Appropriations. (Page 6-12)]; and

WHEREAS, the Fiscal Officer further reports that the amendment(s) and supplement(s) herein are measures providing for appropriations for the current expenses of the village and should go into immediate effect pursuant to Section 731.30 of the Ohio Revised Code.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. That the Annual Appropriation Measure 2019-03 shall be amended as follows:

SECTION 3. DISPENSE WITH THREE READINGS. R.C. 731.17(A)(2) That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 4: IMMEDIATE EFFECT. [RC 731.30] That measures providing for the appropriations for the current expenses of the municipal corporation shall go into immediate effect.
