VILLAGE COUNCIL OF GREENWICH, OHIO ORDINANCE NO: 2021-07

AN ORDINANCE AMENDING THE COMPENSATION ORDINANCE NO. 2016-03 SECTION 1 ADJUSTING THE COMPENSATION OF THE VILLAGE ADMINISTRATOR, AND ADDING SECTION 12 AUTHORIZING COUNCIL BY MOTION TO FIX COMPENSATION IN ACCORDANCE WITH THE ESTABLISHED PAY RANGES, AND DECLARING AN EMERGENCY

WHEREAS, Section 731.13 of the Ohio Revised Code provides that the legislative authority of a village shall fix the compensation of all officers, clerks and employees of the village; and

WHEREAS, Council wishes to amend the compensation range of the Village Administrator; and

WHEREAS, the Compensation Ordinance No. 2016-03 has previously been amended by Ordinance Nos.: 2018-03 and 2019-09.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. That Compensation Ordinance No.: 2016-03 Section 1 is hereby amended as follows:

*Section 1: COMPENSATION OF THE VILLAGE ADMINISTRATOR
The range of annual compensation of the Village Administrator shall be and is hereby established between a minimum of \$39,520.00 and a maximum of ~~\$62,400.00~~ \$74,880.00 payable according to the regular pay cycle of the Village.*

A. Village Administrator base wage shall be as follows: \$48,880/yr. @ 2080 hrs.

*A. The base wage, miscellaneous pay and other benefits for the village Administrator under this section shall be paid from the following funds:
Street, Water, Sewer and Electric.*

B. Employee will contribute 3.5% to Health Care Cost.

SECTION 2. That Wage Ordinance 2016-03 is hereby amended by adding Section 12 as follows:

Section 12: That Council shall by Motion fix the compensation of all officers, clerks and employees of the village in accordance with the pay range established herein.

SECTION 3. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 4. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this Ordinance is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): ***The immediate effectiveness of this ordinance is necessary to provide the continued and uninterrupted operations of the Village.***
