## VILLAGE COUNCIL OF GREENWICH, OHIO ORDINANCE NO.: 20**21**-11

AN ORDINANCE AUTHORIZING THE FISCAL OFFICER TO ESTABLISH A SPECIAL REVENUE FUND PURSUANT TO SECTION 5705.09(F) OF THE OHIO REVISED CODE FOR CONTRIBUTIONS AND DONATIONS RECEIVED FOR THE POLICE K9 PROGRAM

WHEREAS, Village Council recently accepted a donation of a trained electronic storage detection K9; and

WHEREAS, Village Council also authorized a Mutual Aid Agreement Document for the receipt of K9 contributions in Resolution 2021-R-13 passed and adopted August 17, 2021; and

WHEREAS, the Fiscal Officer reports that the Village currently has private contributions and donations available in support of the K9 Program; and

WHEREAS, Section 5705.09(F) of the Ohio Revised Code provides that each subdivision shall establish funds including a special fund for each class of revenue derived from a source other than general property tax, which the law requires to be used for a particular purpose; and

WHEREAS, the Fiscal Officer utilizes the Uniform Accounting Network (U.A.N.) System; and

WHEREAS, to maintain and comply with required accounting practices, the Fiscal Officer finds it necessary to create a special revenue fund to account for any and all K9 contributions and donations.

NOW THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

<u>SECTION 1</u>. That the Fiscal Officer is hereby authorized and directed to take all steps necessary to create a special revenue fund pursuant to ORC 5705.09.09(F) as follows:

Fund 2902 – K9 Program
Revenue Account
2902-820-0000 – Contributions and Donations

<u>SECTION 2</u>. That the purpose of the fund shall be to receive contributions and donations from any and all sources, public and private, designated for use by the Greenwich Police K9 Program.

SECTION 3. That such special revenue funds derived from K9 contributions and donations shall be used only for cost associated with the Village of Greenwich Police K9 Program, including K9 operational expenses, K9 officer wages, K9 maintenance and care, K9 related gear and equipment, K9 related officer training, K9 training, K9 related legal fees, and any other costs or expense specifically relating to the maintenance and operation of the K9 program.

SECTION 4. PUBLIC MEETING. It is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of section 121.22 of the Ohio Revised Code.
