VILLAGE COUNCIL OF GREENWICH, OHIO ORDINANCE NO: 2023-03

AN ORDINANCE AMENDING THE COMPENSATION ORDINANCE NO. 2016-03 SECTION 5, ADJUSTING THE COMPENSATION OF VILLAGE UTILITY WORKER, AND DECLARING AN EMERGENCY

WHEREAS, Section 731.13 of the Ohio Revised Code provides that the legislative authority of a village shall fix the compensation of all officers, clerks, and employees of the village; and

WHEREAS, Council wishes to amend the compensation range of the Utility Worker; and

WHEREAS, the Compensation Ordinance No. 2016-03 has previously been amended by Ordinance Nos.: 2018-03, 2019-09, 2021-07, 2022-19, and 2022-21.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. That Compensation Ordinance No.: 2016-03 Section 5 is hereby amended as follows:

Section 5: COMPENSATION OF THE UTILITY WORKER

The range of annual compensation of the *Full-Time* UTILITY WORKER shall be and is hereby established between a minimum of \$31,200.00 and a maximum of \$43,680.00 \$72,800.00 payable according to the regular pay cycle of the Village.

A. Utility Worker base wage shall be as follows:
Minimum Starting Wage- \$15.00/hr. with \$.50/hr. increase at 6-month anniversary

2-4 years ~~\$16.00/hr.~~ \$16.00/hr.
5-9 years ~~\$17.00/hr.~~ \$17.50/hr.
10-15 years ~~\$18.00/hr.~~ \$19.50/hr.
16-20 years ~~\$20.00/hr.~~ \$21.50/hr.

B. The base wage, miscellaneous pay, and other benefits for the Utility Worker under this section shall be paid from the following funds: Street, Water, Sewer and Electric.

C. Employee will contribute 3.5% to Health Care Cost.

D. Utility worker may be used in Electric, Water, Wastewater, and Street Departments and although assigned to those departments may be used as needed throughout the village operations at the discretion of the Village Administrator.

SECTION 2. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 3. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT.
That by two-thirds vote of all the members elected to the legislative authority, this Ordinance is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s):
The immediate effectiveness of this ordinance is necessary to provide the continued and uninterrupted operations of the Village.

SECTION 4. PUBLIC MEETING. It is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of Section 121.22 of the Ohio Revised Code.

WHEREFORE, this Ordinance/Resolution shall take effect at the earliest period allowed by law.
