## SALE OF PERSONAL PROPERTY

AN ORDINANCE PURSUANT TO R.C. SECTION 721.15(A) AUTHORIZING THE CHIEF OF POLICE TO SELL THE **2006 CROWN VICTORIA POLICE CRUISER** WITH AN ESTIMATED VALUE OF ONE THOUSAND DOLLARS OR MORE THAT IS NO LONGER NEEDED FOR MUNICIPAL PURPOSES
