VILLAGE COUNCIL OF GREENWICH, OHIO RESOLUTION NO. 20<u>23</u>-R-04

A RESOLUTION AUTHORZING THE VILLAGE ADMINISTRATOR TO SUBMIT AN APPLICATION TO THE TRANSPORTATION ALTERNATIVE PROGRAM (TAP) FUNDED THROUGH OHIO DEPARTMENT OF TRANSPORTATION (ODOT) FOR A MULTI-USE RECREATIONAL TRAIL FROM TOWNLINE 79 IN FITCHVILLE TOWNSHIP TO TOWNLINE 187 IN FITCHVILLE TOWNSHIP ALSO EXTENDING FROM OLD U.S. 250 TO ALPHA ROAD IN GREENWICH TOWNSHIP ALSO EXTENDING FROM KNIFFIN ST IN THE VILLAGE OF GREENWICH TO TOWNSEND ST IN THE VILLAGE OF GREENWICH ALSO TOWNLINE 187 TO U.S. 250 AT THE VERMILION RIVER BRIDGE AND DECLARING AN EMERGENCY.

WHEREAS, Transportation Alternative Program (TAP) provides funds to local governments through ODOT for projects that enhance the transportation experience by improving the cultural, aesthetic, and environmental aspects of a Village; and

WHEREAS, the Village has identified the multi-use recreational trail from Townline 79 in Fitchville Township to Township 187 in Fitchville Township also extending from Old U.S. 250 to Alpha Road in Greenwich Township also extending from Kniffin Street in the Village of Greenwich to Townsend Street in the Village of Greenwich also Townline 187 to U.S. 250 at the Vermilion River bridge.

WHEREAS, the Village has been invited by ODOT to participate in the application process.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. The Village Administrator is hereby authorized to submit an application to TAP.

<u>SECTION 2</u>. Upon award the funds will be used for the multi-use pedestrian trail from Townline 79 in Fitchville Township to Townline 187 in Fitchville Township also extending from Old U.S. 250 to Alpha Road in Greenwich Township also extending from Kniffin Street in the Village of Greenwich to Townsend Street in the Village of Greenwich also Townline 187 to U.S. 250 at the Vermilion River bridge.

<u>SECTION 3</u>. <u>DISPENSE WITH THREE READINGS</u>. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

<u>SECTION 4.</u> <u>DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT</u>. That by <u>two-thirds</u> <u>vote</u> of all the members elected to the legislative authority, this Ordinance/Resolution is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): *To expediate the application to the State of Ohio before the January 29, 2023, deadline.*

SECTION 5. PUBLIC MEETING. That it is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of Section 121.22 of the Ohio Revised Code.

WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.
