A RESOLUTION PROVIDING FOR AND CONFIRMING THE MAYOR'S PROBATIONARY APPOINTMENT OF ALEXANDER J. MICHEL TO THE GREENWICH POLICE DEPARTMENT AND DECLARING AN EMERGENCY

RC 737 16

WHEREAS, Section 242.01 of the Greenwich Codified Municipal Code of Ordinances provides that the Greenwich Police Department shall consist of a Chief of Police and such other officers and personnel as determined from time to time by Council; and

WHEREAS, Section 242.025(a) of the Greenwich Codified Municipal Code of Ordinances (See Ord. 883. Passed 4-15-97) provides that an Assistant Chief at the rank of Lieutenant in the Police Department is recognized and therefore established, the position to be filled as recommended by the Police Chief and Mayor; and

WHEREAS, Ohio Revised Code Section 737.16 provides that the mayor shall, when provided by the legislative authority of a village, and subject to its confirmation, appoint all police officers, and

WHEREAS, the Chief of Police reports that the Police Department is presently staffed as follows:

1 full-time Chief of Police; and

1 full-time Assistant Chief-Lieutenant [Greenwich 242.025(a)]; and

2 full time police officer(s); and

 $\underline{4}$ part time police officer(s); and

<u>Variable</u> voluntary-without compensation reserve officer(s) (Greenwich 242.06) (See RC 737.161 Auxiliary)

WHEREAS, the Chief of Police further reports that recently the Police Department's staffing has changed as follows:

Full-time officer Kyle Eith has resigned his full-time position and will transfer to a part-time position.

WHEREAS, the Chief of Police respectfully submits that the current staffing is insufficient to adequately assure proper police protection to the village; and

WHEREAS, the Chief of Police has requested that the Mayor be provided with Council's authority to appoint an additional deputy marshal / police officer; and

WHEREAS, upon the recommendation of the Chief of Police, the Mayor has designated the following as the potential probationary appointee to the department:

Alexander J. Michel Designee has served as a part-time Greenwich Police Officer since 12/6/22

WHEREAS, the Chief of Police reports that the designated probationary appointee has completed the necessary initial officer certification and training; and

WHEREAS, the Chief of Police further reports that the designated probationary appointee has, not more than sixty days prior to receiving this appointment, passed a physical examination required Section 737.16 of the Ohio Revised Code, showing that the person meets the physical requirements necessary to perform the duties of the position as established by the legislative authority: and

WHEREAS, the Chief of Police further reports that the designated probationary appointee has not been previously convicted of or has pleaded guilty to a felony [RC 737.162(B)(1)]; and

WHEREAS, if the position is Full Time, a copy of the physical results report for the designated probationary appointee has been filed with the Ohio Police Pension Fund on behalf of the appointing authority as required by Section 737.16 of the Ohio Revised Code; and

WHEREAS, the Chief of Police recommends that the Mayor's designated probationary appointee

THEREFORE, BE IT RESOLVED, BY COUNCIL, THE LEGISLATIVE AUTHORITY OF THE VILLAGE OF GREENWICH, STATE OF OHIO, (RC 731.18) to wit:

SECTION 1. AUTHORITY. That Council hereby provides the mayor with the authority to appoint an additional deputy marshal / police officer to the police department pursuant to R.C. 737.16.

SECTION 2. CONFIRMATION. That Council hereby confirms the Mayor's probationary appointment of the following deputy marshal / police officer to the Greenwich Police Department:

ALEXANDER J. MICHEL

SECTION 3. That the probationary appointment shall be for a full-time position.

SECTION 4. That the probationary period and appointment shall begin the 3^{rd} day of July 2023.

SECTION 5. That as required by Section 242.07(b) of the Greenwich Municipal Code, all Village patrolmen, whether full time or part time, shall serve a one-year continuous service Probationary period and none shall be finally hired until the appointee has satisfactorily served the probationary period. [See also Section 737.17 of the Ohio Revised Code, See also Section 737.17 of the Ohio Revised Code.]

SECTION 6. That during the probationary period, the probationary patrolman shall receive the probationary rate of compensation plus any yearly increases as are awarded to other village employees. [Section 242.07(b) Greenwich Municipal Code, See also Section 737.17 of the Ohio Revised Code]

SECTION 7. OATH. That the Mayor and Chief of Police are hereby authorized to assure that the newly confirmed probationary police officer is properly sworn into office as required by

SECTION 8. STATIONING. That the Chief of Police shall have exclusive authority over the stationing and transfer of this officer within the police department of the village, under the general rules that the mayor prescribes as provided by Section 737.19 of the Ohio Revised Code.

SECTION 9. SERVICE RECORD. That at the end of the probationary period, the mayor shall transmit to Council a record of such probationary patrolman's service along with the mayor's recommendation thereof and the mayor may, with the concurrence of Council, remove or finally appoint the patrolman. [Section 242.07(b) of the Greenwich Municipal Code. See also Section 737.17 of the Ohio

SECTION 10. REMOVAL OR FINAL APPOINTMENT. That no appointments shall be finally made until the appointee has satisfactorily served his probationary period. Probation shall continue until the mayor and council concur on either removing or finally appointing the officer. (See R.C. 737.17)

SECTION 11. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 12. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this legislation is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): To replace police department staff lost due to department turn over.

SECTION 13. PUBLIC MEETING. That it is found and determined that all formal action of this public body concerning or relating to the passage of this legislation were adopted in a public
