Administrators Report/Zoning: Virgil Giles stated that he and the engineers are looking into grants for the water plant through WSLRA, this grant would be a few years out but it gets Greenwich on the list for the grant. This will help with building a new water plant and possible distribution lines. The 10-year contract is complete with the water tower on Maple St, the inspections are good. Designing for the new lift station on Townsend. Virgil said the lagoons would be better if there were baffles and he would like to increase irrigation that would help with the duckweed. OPWC is still in limbo waiting on results to see if Greenwich scores high enough. ODOT will be paving 224 this year. There is also an additional EAP grant that one more comment/contact is needed. Virgil and the engineers are looking for financing for the electrical substation. Zoning is quiet, he is continuing to work on the zoning map. Our cost for kilowatt and megawatts is down from last year. Virgil was asked about the digger derrick on New St that is holding up the pole with a rope and Virgil stated that he is aware of it and at this time his employees are fairly new and he needs a ground lineman to help. Virgil is also working on the nature works grant.

**Chief Fox Report:** Mr. Lloyd made Officer Zehner aware of phone calls he is receiving about the trucks running throughout the night and being a nuisance. Officer Zehner stated to have the residents call the PD and make a complaint.
