**Visitor's Addressing:** Jerry Miller and Lisa Hauke (22 W Main St) came to council to discuss the problems they are having with their utility bills. Resident Hauke, and partner/electrician Miller brought in paperwork as evidence that they feel their meters caused an increase in electrical use for January, Miller stated that he saw the meter spinning rapidly so he pushed in the meter and the meter slowed down, two days later the meter was taken away as requested by the owner to have the meter tested. Virgil reached out to a couple sources and found the City of Galion had the right equipment to test and Virgil received the results. The resident is not happy with how the situation has been handled and requested that someone other than the Administrator Mr. Giles to contact her with a result to her request to have her bill adjusted to an average bill. Further discussion on the way the process of the testing took place, the Solicitor at one point stated some of the information given to Hauke was hearsay and not true, as Virgil tried to correct information being said. The Mayor and the Solicitor will be reviewing the Villages records and the evidence and updating their knowledge on the utility by-laws and apologized that there would not be an answer given at this time.
