## VILLAGE COUNCIL OF GREENWICH, OHIO RESOLUTION NO. 20<u>23</u>-R-22

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR TO APPOINT ONE ADDITIONAL POLICE OFFICER TO THE GREENWICH POLICE DEPARTMENT SUBJECT TO COUNCIL CONFIRMATION AND DECLARING AN EMERGENCY

WHEREAS, Section 737.16 of the Ohio Revised Code provides that the mayor shall, when provided by the legislative authority of a village, and subject to its confirmation, appoint all police officers, and

WHEREAS, the Chief of Police reports that his police force is in need of additional part time police officer to help relieve overtime and safety of full-time officers; and

WHEREAS, the Chief of Police further reports that the Greenwich Police Department is presently staffed with <u>4</u> full time officers and <u>4</u> part time officers: and

WHEREAS, the Chief of Police respectfully submits that the current staffing is insufficient to adequately assure proper police protection to the village; and

WHEREAS, the Chief of Police is requesting Council authorize the Mayor to appoint <u>1</u> additional officer(s) to the Greenwich Police Department subject to Council confirmation.

NOW THEREFORE, BE IT <u>RESOLVED</u> BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731 18)

<u>SECTION 1</u>. That the Mayor is hereby authorized and directed to appoint  $\underline{1}$  additional police officer(s) to the Greenwich Police Department.

SECTION 2. That this authorization shall be for  $\underline{1}$  additional police officer(s).

<u>SECTION 3</u>. That the Mayor's potential appointee/appointees shall be submitted to Council for confirmation prior to being placed on duty.

SECTION 4. That upon confirmation, the appointee shall be required to satisfactorily complete a probationary period prior to final appointment. [See Section 242.07 of the Greenwich Municipal Code. See also Section 737.17 of the Ohio Revised Code.]

<u>SECTION 5</u>. That at the end of the probationary period, the mayor shall transmit to the legislative authority of the village a record of such employee's service with recommendations thereon and may, with the concurrence of the legislative authority, remove or finally appoint the employee. [See Section 242.07 of the Greenwich Municipal Code. See also Section 737.17 of the Ohio Revised Code.]

<u>SECTION 6</u>. That the Mayor and Chief of Police shall assure that the potential appointee shall have, not more than sixty days prior to receiving such appointment, passed a physical examination showing that the person meets the physical requirements necessary to perform the duties of the position to which the person is to be appointed as established by the legislative authority and required by Section 737.16 of the Ohio Revised Code.

SECTION 7. That, if the position is full time, the Mayor and Chief of Police shall, prior to making any such appointment, file a copy of the physical results report for the designated probationary appointee has been filed with the Ohio Police Pension Fund on behalf of the appointing authority as required by Section 737.16 of the Ohio Revised Code.

SECTION 8. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this Ordinance/Resolution is
