RESOLUTION NO. 2023-R-24

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A CONTRACT FOR THE PURCHASE OF USED EQUIPMENT WITHOUT BIDDING

WHEREAS the Village Administrator reports that the village needs a Backhoe with attachments; and

WHEREAS, the Village Administrator further reports that he has located a used Backhoe with some attachments and requests to be authorized to purchase the used equipment without bidding; and

WHEREAS, the Greenwich Code 206.02(g) (11) exempts the purchases of used equipment from competitive bidding requirements (see also R.C. 735.052)

WHEREAS, The Village Administrator submits that funds have been appropriated and remain encumbered for such purpose. (See R.C. 735.052)

THEREFORE, BE IT ORDAINED, by the Council, the legislative authority of the Village of Greenwich, State of Ohio, (RC 731.18) to wit:

SECTION 1. The Village Administrator is hereby authorized to enter into a contract without bidding for the purchase of a used Backhoe with attachments at a price not to exceed \$73,000.

SECTION 2. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 3. DECLARATION OF EMERGENCY: That by two-thirds vote of all the members elected to the legislative authority, this legislation is hereby declared to be an emergency measure, pursuant to RC 731.30, necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): ***To replace a old backhoe that is needed for emergency water and sewer line repairs.***

SECTION 4. PUBLIC MEETING. It is found and determined that all formal action of this public body concerning or relating to the passage of this legislation were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of section 121.22 of the Ohio Revised Code.

WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.
