SUPPLEMENTAL APPROPRIATION MEASURE RC 5705.38

AN ORDINANCE SUPPLEMENTING AND AMENDING THE $\underline{2023}$ ANNUAL PERMANENT APPROPRIATION ORDINANCE AND DECLARING AN EMERGENCY

WHEREAS, an ordinance by village council is necessary when the appropriation amendment will result in a reallocation of the line-item amounts approved in the village's permanent appropriation ordinance [See Village Officer's Handbook, March 2019, Chapter Six: Accounting Procedures, Section IX Amending Appropriations. (Page 6-12]; and

WHEREAS, the Fiscal Officer advises that it is necessary to amend the Annual Appropriation Ordinance to appropriate General Fund resources.

WHEREAS, the Fiscal Officer reports that the amendment(s) and supplement(s) herein are measures providing for appropriations for the current expenses of the village and should go into immediate effect pursuant to section 731.30 of the Ohio Revised Code.
