4. There will be a primitive camping area set up
  - a. Will contact county to ask for permit for temporary campsite.
  - b. The cost will be \$25.00 per tent.
5. There will be three food trucks at event to provide food and drinks to the guests.
6. There will be T-shirt, koozies, and wristbands for sale at the event.
7. The Bands will be given their check for the event during the set up.
  
8. Any profit made will be deposited back into the park account.


Leah is creating flier with logo: Party for the Park. She is also making T-shirts. We are putting together banners for sponsorship.


We are going to need a police presence at the event.


Wrists bands will be handed out for ticket holders.
