MEETINGS OF THE LEGISLATIVE AUTHORITY
TIME AND PLACE
RC 731.46

AN ORDINANCE PRESCRIBING THE TIME AND PLACE OF THE MEETINGS OF VILLAGE COUNCIL AND DECLARING AN EMERGENCY

WHEREAS, Section 731.46 of the Ohio Revised Code provides that the meetings may be held at such time and place as is prescribed by ordinance and reads as follows: [*See also Greenwich Council Rules*]

*Section 731.46 | Meetings of legislative authority.
The legislative authority of a municipal corporation shall not be required to hold more than one regular meeting in each week. **The meetings may be held at such time and place as is prescribed by ordinance** and shall, at all times, be open to the public. The mayor, or any three members of the legislative authority may call special meetings upon at least twelve hours' notice to each member, served personally or left at his usual place of residence.*

WHEREAS, the time and place for council meetings was previously prescribed in Ord No.: 2002-O-04, 2021-O-04, and 2023-O-01. The Time and place for council meetings is also noted within the Rules of Council.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (*RC 731.18*)

SECTION 1: That Village Council hereby prescribes that REGULAR SESSIONS of council meetings shall be held at the following time and place:

TIME: **First and Third Tuesday of each month** promptly at **6:00 o'clock PM.**
PLACE: **Village Hall, located at 45 Main Street, Greenwich, Ohio 44837.**

SECTION 2: That any ordinance or rule inconsistent herewith is hereby repealed, rescinded, and replaced.

SECTION 3. That the mayor, or any three members of the legislative authority may call special meetings upon at least twelve hours' notice to each member, served personally or left at his usual place of residence. (*See RC 731.46*)

SECTION 4. DISPENSE WITH THREE READINGS. [*R.C. 731.17(A)(2)*] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 5. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this Ordinance/Resolution is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s):

To begin the new regular meeting schedule in July of 2024.

SECTION 6. PUBLIC MEETING. That it is found and determined that all formal actions of this public body concerning or relating to the passage of this Resolution / Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal

action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of Section 121.22 of the Ohio Revised Code.
WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.
