ORC 731.141 Greenwich Code 232.09

AN ORDINANCE AMENDING SECTION 232.09 OF THE GREENWICH CODIFIED MUNICIPAL CODE OF ORDINANCES REGARDING THE FISCAL OFFICER ASSISTING THE VILLAGE ADMINISTRATOR AS CENTRAL PURCHASING AGENT AND DECLARING AN EMERGENCY.

WHEREAS, Section 731.141 of the Ohio Revised Code provides in part as follows:

The legislative authority of a village may provide, by ordinance, for central purchasing for all offices, departments, divisions, boards, and commissions of the village, under the direction of the village administrator, who shall make contracts, purchase supplies or materials, and provide labor for any work of the village in the manner provided by this section.

WHEREAS, the Village provided by ordinance for central purchasing under the direction of the village administrator by Ord. 708, passed 11-16-82.

232.09 PURCHASING AGENT.

The Administrator is hereby appointed the Purchasing Agent for the Village. (Ord. 708. Passed 11-16-82.)

WHEREAS, Section 735.273 of the Ohio Revised Code provides in part as follows:

The village administrator shall appoint officers, employees, agents, clerks, and assistants, provided such positions are first authorized by the legislative authority of the village...

NOW, THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. AMEND. That Section 232.09 of the Greenwich Codified Municipal Code of Ordinances is hereby amended as follows:

232.09 CENTRAL PURCHASING AGENT.

The Administrator is hereby appointed the Purchasing Agent for the Village.

- <u>a.</u> Village Council hereby provides for central purchasing for all offices, departments, divisions, boards, and commissions of the village, under the direction of the village administrator, who shall make contracts, purchase supplies or materials, and provide labor for any work of the village in the manner provided by ORC 731.141.
- b. The Fiscal Officer shall assist the village administrator in the administrator's duties as central purchasing agent.
