Legislation:

The council passed 5 to 1 an emergency legislation to authorize the acquisition, acceptance, and recording of certain perpetual sanitary sewer easements across the parcels necessary for the phase IV of the Townsend lift station sanitary sewer project and declaring an emergency

The council passed 5 to 1 to repair a vital transformer with Lake Park without formal bidding and authorizing the fiscal officer to expend the money necessary for the emergency repairs

Resolution:

The council passed 5 to 1 to appoint Carson J. Teynor to the police department

New business:

The council accepted the officer for the fire department to remove and rebuild the basketball courts.

The council approved the concert for the park and the beer garden that GIG will organize.

Executive Session:


The council entered executive session at 6:58pm and exited at 7:11pm.

Adjournment:


Dorene motioned to adjourn and Lynne seconded her motion.
