AN ORDINANCE FINDING AND BEING SATISFIED THAT THERE IS GOOD CAUSE FOR SUCH CHANGE OF NAME; AND FINDING THAT IT WILL NOT BE DETRIMENTAL TO THE GENERAL INTEREST AND THAT IT SHOULD BE MADE; AND DECLARING THE NAME OF E UNION STREET CHANGED TO LACEY LANE; BUT LIMITED IN LOCATION AND SCOPE TO THE SECTION ACCESSIBLE FROM N KNIFFIN ST.

WHEREAS, Section 723.04 of the Ohio Revised Code permits Village Council to change the name of streets by ordinance upon petition and reads:

ORC Section 723.04 | Change of name, vacating, or narrowing streets on petition.

The legislative authority of a municipal corporation, on petition by a person owning a lot in the municipal corporation praying that a street or alley in the immediate vicinity of such lot be vacated or narrowed, or the name thereof changed, upon hearing, and upon being satisfied that there is good cause for such change of name, vacation, or narrowing, that it will not be detrimental to the general interest, and that it should be made, may, by ordinance, declare such street or alley vacated, narrowed, or the name thereof changed. The legislative authority may include in one ordinance the change of name, vacation, or narrowing of more than one street, avenue, or alley. The original ordinance or a certified copy thereof shall be recorded in the official records of the county recorder.

To Whom It May Concern,

This is a petition to change the name of the east section of East Union Street.

- 1. The name of the current street is East Union
- 2. The scope of the requested change is only the section accessible by North Kniffin St. This would be the east end of East Union Street.
- 3. The good cause for the name change is to address safety concerns and improve emergency response time. The through street was terminated when the grade crossing with CSX was removed. This resulted in East Union becoming a dead-end street on both sides of the former crossing. This has caused significant confusion for first responders and has led to delayed response times during emergencies. Examples of issues are emergency personnel have been called for 41 East Union, and often accessed East Union from Townsend Street, only to find the emergency was on the other side of the former railroad crossing. They then had to turn around and locate an alternate route, causing delays in critical situations. By renaming the east section of East Union Street, we can eliminate this confusion and ensure timely responses by first responders.
- 4. The name change will not be detrimental to the general interest of the residents for the reasons listed above. The name change will provide clarity and simplify navigation for residents. From street maintenance, trash pickup, and parcel delivery, this name change will not in any way be detrimental to the general interests but will instead serve to enhance safety and operational efficiency for all.
- 5. Printout of tax map (See enclosed)
- 6. The proposal for the new name is Bo Lacey Way. After speaking with residents and members of council, everyone agrees this is the name most fitting. This keeps the tradition of naming streets after upstanding members of the community. Bo Lacey lived at 41 East Union, having built the home for his wife Charlotte and himself to live out their retirement years. Charlotte continues to reside there. Bo regularly volunteered his time to help the citizens of Greenwich. He would routinely do home repairs for single mothers who could not afford to pay. He also volunteered his time to South Central Schools with various projects including the restroom facility and the press box at South Central Football field and was always helpful when asked by city employees about various projects in town. Bo passed away at his home and is laid to rest at Greenlawn cemetery, Greenwich.

In conclusion we believe this name change will address current safety concerns, improve emergency response times, and honor the lasting contributions of Bo Lacey to the Greenwich community. We respectfully request the council's consideration and approval of this proposal.


