ESTABLISHMENT OF FUND
ORC 5705.09
New Utility Fund Line Items

AN ORDINANCE ESTABLISHING NEW ADDITIONAL LINE ITEMS WITHIN THE UTILITY FUNDS
AND DECLARING AN EMERGENCY

WHEREAS, Section 5705.09 of the Ohio Revised Code states that each subdivision shall establish certain funds and reads as follows:

Section 5705.09 | Establishment of funds.

Each subdivision shall establish the following funds:

- (A) General fund;
- (B) Sinking fund whenever the subdivision has outstanding bonds other than serial bonds;
- (C) Bond retirement fund, for the retirement of serial bonds, notes, or certificates of indebtedness;
- (D) A special fund for each special levy;
- (E) A special bond fund for each bond issue;
- (F) A special fund for each class of revenues derived from a source other than the general property tax, which the law requires to be used for a particular purpose;
- (G) A special fund for each public utility operated by a subdivision;
- (H) A trust fund for any amount received by a subdivision in trust.

WHEREAS, as required by ORC 5705.09(G) the Village has established and maintains special funds for each utility operated by the subdivision; and

WHEREAS, the Fiscal Officer has requested Village Council add new additional line items to the UTILITY Funds; and

WHEREAS, the Village Council wishes to accept the recommendation of the Fiscal Officer and create additional new line items in the UTILITY Funds.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. NEW LINE ITEM. That the Fiscal Officer is hereby authorized and directed to take all steps necessary to add a new additional line item to the WATER Fund as follows:

WATER FUND

SECTION 2. NEW LINE ITEM. That the Fiscal Officer is hereby authorized and directed to take all steps necessary to add a new additional line item to the SEWER Fund as follows:

SEWER FUND

SECTION 3. NEW LINE ITEM. That the Fiscal Officer is hereby authorized and directed to take all steps necessary to add a new additional line item to the SEWER IMPROVEMENT Fund as follows:

SECTION 4. NEW LINE ITEM. That the Fiscal Officer is hereby authorized and directed to take all steps necessary to add a new additional line item to the **ELECTRIC** Fund as follows:

ELECTRIC FUND

5301-519-348-0000 - TRAINING SERVICES For Electric Dept. employee training
5301-740-344-0000 - TAX COLLECTION FEES For Tax Fees

SECTION 5. DISPENSE WITH THREE READINGS. That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days. [ORC 705.15 and 731.17(A)(2)]

SECTION 6. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this legislation is hereby declared to be an emergency measure pursuant to ORC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s):

The Fiscal Officer wishes to utilize the new line items for the 2025 Permanent Appropriations.

SECTION 7. PUBLIC MEETING. That it is found and determined that all formal action of this public body concerning or relating to the passage of this legislation were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of section 121.22 of the Ohio Revised Code.


WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.




