New <u>Utility</u> Fund Line Items

AN ORDINANCE ESTABLISHING NEW ADDITIONAL LINE ITEMS WITHIN THE <u>UTILITY</u> FUNDS AND DECLARING AN EMERGENCY

WHEREAS, Section 5705.09 of the Ohio Revised Code states that each subdivision shall establish certain funds and reads as follows:

Section 5705.09 | Establishment of funds.

Each subdivision shall establish the following funds:

- (A) General fund:
- (B) Sinking fund whenever the subdivision has outstanding bonds other than serial bonds;
- (C) Bond retirement fund, for the retirement of serial bonds, notes, or certificates of indebtedness;
- (D) A special fund for each special levy;
- (E) A special bond fund for each bond issue;
- (F) A special fund for each class of revenues derived from a source other than the general property tax, which the law requires to be used for a particular purpose;
- (G) A special fund for each public utility operated by a subdivision;
- (H) A trust fund for any amount received by a subdivision in trust.

WHEREAS, as required by ORC 5705.09(G) the Village has established and maintains special funds for each utility operated by the subdivision; and

WHEREAS, the Fiscal Officer has requested Village Council add new additional line items to the <u>UTILITY</u> Funds; and

WHEREAS, the Village Council wishes to accept the recommendation of the Fiscal Officer and create additional new line items in the <u>UTILITY</u> Funds.

NOW THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (RC 731.18)

SECTION 1. NEW LINE ITEM. That the Fiscal Officer is hereby authorized and directed to take all steps necessary to add a new additional line item to the **WATER** Fund as follows:
