VACATION *Greenwich Codified Municipal Code 252.03* Full Time Service Credit FISCAL OFFICER

A RESOLUTION AUTHORIZING VACATION TIME AND FULL-TIME SERVICE CREDIT FOR THE NEW FISCAL OFFICER AND DECLARING AN EMERGENCY

WHEREAS, the former Village Fiscal Officer recently ended employment effective 01/30/2025; and

WHEREAS, the current Village Fiscal Officer was recently appointed pursuant to ORC 733.262 and Greenwich Code Section 236.015 and began work on 02/17/2025; and

WHEREAS, the current Fiscal Officer has requested full time service credit that would permit one week vacation in the first year of employment; and

WHEREAS Chapter 252, Section 252.08(a) of the Greenwich Codified Municipal Code of Ordinances provides in part as follows:

CHAPTER 252 *Employees Generally*

252.03 VACATIONS.

(a) All regular full-time employees of the Village, whether receiving compensation on a yearly, monthly or hourly basis, shall be entitled to receive vacations as follows effective with 2021 vacations:

(1) One week of vacation with full pay for each employee who has been continuously employed in full-time service for one year or more, with satisfactory service.

(2) Two weeks of vacation with full pay for each employee who has been continuously employed in full-time service for two years or more, with satisfactory service.

(3) Three weeks of vacation with full pay for each employee who has been continuously employed in full-time service for ten years or more, with satisfactory service.
(Ord. 388. Passed 2-3-56.)

(4) Four weeks of vacation with full pay for each employee who has been continually employed in full-time service for fifteen years or more, with satisfactory service.
(Ord. 897. Passed 8-18-98.)

WHEREAS Village Council would like to authorize the necessary full-time service credit to permit the new Fiscal Officer to be able to take one week's vacation in the first year of employment.

THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO:
(RC 731.18):

SECTION 1. VACATION TIME CREDIT. That Village Council hereby authorizes and approves **ONE WEEKS OF VACATION** with **FULL TIME SERVICE CREDIT OF ONE YEAR** pursuant to Greenwich Code Section 252.03(a)(1) for the newly appointed **FISCAL OFFICER** **retroactive to 02/17/2025**. Such full-time service credit herein shall be used for vacation purposes only and shall expire at such a time where the current employment of the **Fiscal Officer** is discontinued.

SECTION 2. RETROACTIVE. That the Full Time Service Credit will begin retroactively on 02/17/2025. The Village Council expressly intends the credit adopted herein to operate retrospectively pursuant to Section 1.48 of the Ohio Revised Code.

Council further finds that the retroactive application does not take away or impair vested rights acquired under current existing laws, nor does it create new obligations, nor imposes a new duty, nor attaches a new disability, in respect to transactions or considerations already passed and adopted.

SECTION 3. SEVERABILITY. This legislation and the various parts, sentences, paragraphs, sections, and clauses thereof are hereby declared to be severable. Should any part, sentence, paragraph, section, or clause be declared unconstitutional, null, or void by a court of competent jurisdiction, such declaration shall not have any effect on the validity of the remaining parts, sentences, paragraphs, sections, and clauses of this legislation.

SECTION 4. PERSONNEL FILE. The Fiscal Officer, on behalf of the mayor, is hereby instructed to place a copy of this legislation in the Personnel File of the current FISCAL OFFICER.

SECTION 5. DISPENSE WITH THREE READINGS. [ORC 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 6. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this legislation is hereby declared to be an emergency measure pursuant to ORC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s):

The current FISCAL OFFICER took office on 02/17/2025

SECTION 7. PUBLIC MEETING. That it is found and determined that all formal action of this public body concerning or relating to the passage of this legislation were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of Section 121.22 of the Ohio Revised Code.

WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.
