The council approved meeting minutes from July 01, 2025 council meeting.

Invited Guests / Comments from floor:

G. Bovia informed everyone that she went out to the cemetery and weeded the flowers that were put in by the master gardener. She reached out to Kirk Dittman to ask about getting stone put around the flowers so weeds can stay out of it. Krugman asked that it is edged so it is easier to mow around.

Committee council reports & Village Representative Reports:

Record retention meeting is scheduled for November 18th at 5:45pm.

The Park Committee meeting is scheduled for August 5th at 5:00pm.

The park raised \$485 dollars with 50/50 during the festival. August 9th is Party for the Park. There will be a sign-up sheet at the next park meeting to help to sign up for different time periods. There are talks for a gospel concert to be held September 20th called Worship in the Woods. It will be \$10 per person.

Village Administrator report:

Hydration systems were delivered at the utility building. The library has gravel walkways now and crosswalks will be put in in the next week or so. There was a water leak in the park. It is now fixed.

Chief of Police report:

Touch a Truck is scheduled for Saturday.

Solicitor -

The chief was wanting to get the mitigation hazard legislation plan passed. Mr. Palmer asked if the council wanted to sneak it onto the agenda for this meeting or if we could wait and have it on August 5th meeting. The council agreed to wait for the first meeting in August.

Mayor:

Mayor shared the thank you note sent from the Saunders family.

Legislation:

Mayor asked why Resolution 2025-R-30 needed to be an emergency. D. Beverly explained the need to get the building demolished and that cannot be done until the items are disposed of.

Resolution 2025-R-30 an emergency resolution finding that certain personal property is not needed for public use and that the property has no value and directing the village administrator to discard or salvage that property. Resolution 2025-R-30 approved.

The council approved the third reading of resolution 2025-R-27, a resolution authorizing the drawings of a warrant in payment of an amount due in excess of three thousand dollars and approving a "then & now" certification by the fiscal officer pursuant to section §5705.41(D)(1) of the Ohio Revised Code. Resolution 2025-R-27 was approved.
