SALE OF PERSONAL PROPERTY
R.C. 715.15

AN ORDINANCE PURSUANT TO R.C. SECTION 721.15(A) AUTHORIZING THE CHIEF OF POLICE TO SELL THE 2006 CROWN VICTORIA POLICE CRUISER WITH AN ESTIMATED VALUE OF ONE THOUSAND DOLLARS OR MORE THAT IS NO LONGER NEEDED FOR MUNICIPAL PURPOSES

WHEREAS, Section 721.15(A) of the Ohio Revised Code provides that personal property not needed for municipal purposes, the estimated value of which is less than one thousand dollars, may be sold by the board or officer having supervision or management of that property. If the estimated value of that property is one thousand dollars or more, it shall be sold only when authorized by an ordinance of the legislative authority of the municipal corporation and approved by the board, officer, or director having supervision or management of that property; and

WHEREAS, the Chief of Police reports that the police department has supervision or management of the following property:

WHEREAS, the Mayor and Chief of Police report that the personal property described herein has an estimated value of more than one thousand dollars; and

WHEREAS, the Chief of Police recommends and approves the sale of the property described herein.

NOW THEREFORE, BE IT ORDAINED, BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO, (RC 731.18) to wit:

SECTION 1: UNNEEDED That Council hereby finds and determines that personal property described herein is no longer needed for municipal purposes.

SECTION 2: VALUE. That Council further finds and determines that personal property described herein has an estimated value of more than one thousand dollars.

SECTION 3: SALE AUTHORIZED. That the Chief of Police is hereby authorized to sell the following personal property:

SECTION 4. HIGHEST AND BEST BIDDER. That pursuant to R.C. 715.15(A) the Chief of Police shall make a written contract with the highest and best bidder after advertisement for not less than two nor more than four consecutive weeks in a newspaper of general circulation

That it is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of Section 121.22 of the Ohio Revised Code.
