A RESOLUTION APPROVING THE RECREATION CENTER USER AGREEMENT,  
THE RENTAL FEE SCHEDULE, AND THE RENTAL FORMS AS RECOMMENDED BY  
THE RECREATION CENTER ADVISORY BOARD.

WHEREAS, ORC 755.12 permits a municipal legislative authority to maintain and operate recreation facilities which includes INDOOR RECREATION CENTERS and reads in part:

*ORC Section 755.12 | Municipal corporations... may maintain and operate recreation facilities.  
The legislative authority of a municipal corporation, ...may designate and set apart for use as parks, playgrounds, playfields, gymnasiums, public baths, swimming pools, or indoor recreation centers, any lands or buildings owned by any such municipal corporation...and not dedicated or devoted to other public use. Such municipal corporation...may, in the manner provided by law for the acquisition of land or buildings for public purposes in such municipal corporations...acquire lands or buildings therein for such use.*

WHEREAS, the Village of Greenwich has codified its regulations of Reservoir Lake Park in Chapter 1066 of the Village of Greenwich Codified Municipal Code of Ordinances; and

WHEREAS, Greenwich Village Council enacted a Resolution of Authorization permitting the construction, donation and dedication of an indoor Recreation Center in Reservoir Lake Park via Resolution No.: 2025-R-43 passed and adopted on the 7<sup>th</sup> day of October 2025; and

WHEREAS, at the recommendation of the Donor and the Park Committee, Village Council amended the Codified Municipal Code Chapter 1066 to provide for a Reservoir Lake Park Recreation Center ADVISORY BOARD in Ord No.: 2026-O-10 passed and adopted on the 6<sup>th</sup> day of May, 2026; and

WHEREAS, the Reservoir Lake Park, Gathering Grove Recreation Center ADVISORY BOARD has submitted the Recreation Center User Agreement, Rental Fee Schedule, and Rental Forms to Village council for review and approval.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF GREENWICH, STATE OF OHIO: (ORC 731.18)

**SECTION 1. APPROVAL.** That Village council hereby **APPROVES** the Reservoir Lake Park, Gathering Grove Recreation Center 1)User Agreement, 2)Rental Fee Schedule, and 3)Rental Forms submitted by the Reservoir Lake Park Recreation Center Advisory Board as follows

SECTION 2. That the Village Administrator is hereby directed and instructed to coordinate efforts with the Mayor, the Park Committee of Village Council, the fiscal Officer and the Recreation Center Advisory Board to assure compliance with Recreation Center User Agreement, Rental Fee Schedule, and Rental Forms adopted herein.

SECTION 3. INSURANCE. That on the suggestion of the Recreation Center Advisory Board, the Fiscal Officer is hereby instructed to submit and forward any and all documents approved herein to the Village Insurance provider as may be necessary.

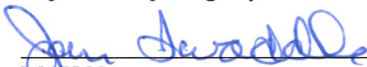

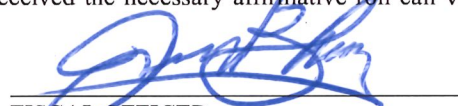
WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.
