Dear Greenwich Resident,

I have enclosed a Village of Greenwich Individual Tax Questionnaire. This information you provide will only be used to set up an income tax account with the Village of Greenwich.

According to Section 881.011 and 881.012 of the Codified Ordinances:

**881.011 AUTHORITY TO LEVY TAX**

(a) The tax on income and the withholding tax established by this Chapter 881 are authorized by Article XVIII, Section 3 of the Ohio Constitution. The tax on income and the withholding tax established by this Chapter 881 are deemed to be levied in accordance with, and to be consistent with, the provisions and limitations of Ohio R.C. Chapter 718 (ORC 718). This chapter is deemed to incorporate the provisions of Ohio R.C. Chapter 718.

(b) The tax is an annual tax levied on the income of every person residing in or earning or receiving income in the municipal corporation, and shall be measured by municipal taxable income. The Municipality shall tax income at a uniform rate. The tax is levied on Municipal Taxable Income, as defined herein.

**881.012 PURPOSE OF TAX; RATE.**

(a) To provide funds for the purposes of general Municipal operations and other Municipal purposes, such as maintenance, new equipment, service and facilities and capital improvements.

(b) There is hereby levied a tax upon earnings at the rate of one percent (1%).

(c) The portion of the net profits attributable to the Village of a taxpayer conducting a business, profession or other activity, both within and without the boundaries of the Village, shall be determined as provided in Section 881.013 and in accordance with the rules and regulations adopted by Council pursuant to this chapter.
